

## **ULAX Photo / Video / Audio Consent Form**

In consideration for your minor child's (hereinafter, "Participant") participation in any events and activities hosted by University Lacrosse LLC (hereinafter, ULAX LLC or ULAX), and for being granted permission to enter, for any purpose, Restricted Areas with which we are affiliated ("Restricted Area" is hereinafter defined as any area where ULAX events and activities are held), the Participant and Participant's parent and/or legal guardian ("Participant's Guardian") agrees and consents to the following:

I, the undersigned, consent to the use, by University Lacrosse LLC and any of its parents, affiliates, subsidiaries, licensees and assigns ("ULAX"), of Participant's participation and appearance including, but not limited to, my and/or Participant's image, voice, performances, stories, actions or statements, in video recording(s), audio recording(s), audiovisual recording(s), motion picture film(s), soundtrack(s), photograph(s), printed matter or any other medium now known or hereafter devised (collectively "Recordings"). ULAX also has my explicit permission to use Participant's and/or my name, likeness, voice and biographical material in connection with the Recordings.

I hereby grant ULAX title and all rights, including any copyright and trademark rights, to the Recordings made of Participant and/or me by ULAX beginning on the start date of the ULAX event for which Participant has joined. As such, I agree that all such Recordings and any reproductions thereof, and all plates, negatives, recording tape, and digital files shall be and remain the sole and exclusive property of ULAX.

In addition, I hereby understand and agree that ULAX may edit, re-record, create derivative works of, duplicate, reproduce, copyright, sell, broadcast, publicly display, publicly perform, and/or distribute the Recordings whether in whole or in part, for any purpose as determined in ULAX's sole discretion.

In addition, I waive all claims for compensation or damages based on the use of Participant's and/or my image or voice, or both, by ULAX, including, but not limited to, actions in the form of copyright, trademark, tort, or warranty and I waive any right to inspect or approve the finished Recordings that may be used in conjunction therewith or to the eventual use that it might be applied.

I understand that this consent is perpetual, that I may not revoke it, and that it is binding on my heirs and assigns. ULAX shall have the irrevocable right, at its sole discretion, to assign this agreement or any rights, duties and obligations hereunder to any party or entity.

I further represent that Participant's participation with ULAX, including the use of Participant's and/or my image and/or voice in any resulting materials, will not infringe upon the rights of any third party.

By electronically signing this waiver, I hereby certify that I am over eighteen (18) years of age and am competent to contract in my own name and the name of Participant insofar as the above is concerned. If I am under eighteen (18) years of age, my parent(s) and/or guardian(s) have read this document and have given their consent by electronically signing this waiver.

This Agreement shall be governed by the laws of the State of Colorado, without respect to its conflict of laws principles. Any claim or dispute between Participant or Minor's Guardian and ULAX that arises in whole or in part from the Site shall be decided exclusively by a court of competent jurisdiction located in Denver County, Colorado.
